Journal of yesterday read and approved. Mr. Hall, by leave, introduced House File No 3: A Joint Resolution for the purpose of protecting the citizens, and keeping the peace in Counties bordering on the line of the State of Missouri, which was read a first and second time and referred to the Committee on Federal Relations.

Mr. Hall, by leave, introduced the following resolution, which

was adopted:

Resolved: That the Committee on Federal Relations, be and they are hereby instructed to prepare and report a bill to this House fully carrying out the purposes and objects set forth in the joint resolution this day referred to them in relation to the protection of the border citizens residing near the line dividing the State of Iowa from the State of Missouri.

Mr. Tompkins, by leave presented a petition praying for the relief of the securities of the School Fund Commissioner of Tama

County, asking that it be referred to a Special Committee.

Mr. Caldwell moved to lay the petition on the table, which mo-

tion did not prevail.

Mr. Baker moved its reference to the Committe on Schools and State University. Carried.

The Speaker presented a communication to the House on the

same subject, which was referred to the same committee.

Mr. Clagett announced the death of Hon Calvin J. Price, late member from Lee County, in the following remarks, which on motion of Mr. Beal, were ordered to be spread upon the Journal:

Mr. Speaker-I have been selected by my colleagues on this floor, to perform the painful duty of announcing to this House, the death of Calvin J. Price, late a Representative here from the

County of Lee.

But a few short months ago, sir, when this body was in session my late colleague was among us, engaged in the duties which his constituents had with so much confidence entrusted to his care; we, sir, can bear witness to his fidelity in the discharge of that trust; for although he was suffering during the whole session, great mental depression arising from misfortunes, which, his too confiding and generous nature had brought upon him; yet sir, at the opening of this House, and each day afteward his seat was never found

His urbanity and uniform kindness toward the members of this House are well known to us all and treasured up in our hearts. These traits of his character which did so greatly distinguish the man were not the adventitious circumstanes of a cold, unmeaning, courtly association, but the natural outpouring of a noble and generous nature which led him as if by instinct to seek the happiness of others, even at the sacrifice of his own. As a member of the Legislature, Mr. Price's mind evinced that solid character for usefulness rather than ornament, which gave him such a hold on the confidence of his constituents. He but rarely took part in the discussions of this body, but when he did so his remarks were characterized by prudence, sound judgment, and a clear appreciation of the merits of the subject under consideration. No member of this House more sincerely desired to reflect the will of his constituents that Mr. Price, no selfish motive ever influenced him in the discharge of his official duties, and no Representative was ever more beloved and trusted by his constituents than he. And his death has left a vacancy in this House which is not easily filled. We his late colleagues, who had the best means of knowing and appreciating his nobleness of character, more keenly feel his loss, as our counselor and friend upon whose sound judgment and disinterested advice we could confidently rely.

Mr. Price was a native of the State of North Carolina, but had resided in the Territory and State of Iowa for the last twenty-four years. He was a member of the first Territorial Legislature, member of the Council, and was frequently elected to both branches of

the State Legislature.

In early life he was without fortune and had to depend on his own exertions for the means of support, and nobly did he perform his duty in that respect. He was the architect of his own fortune, and by the labor of his hands on his own acres, he had accumulated a handsome fortune for the comfortable maintenance of himself and family in his declining years; but which was lately greatly impaired by those who took advantage of his too generous and confiding nature.

This misfortune pressed heavily on the mind of our deceased friend and hastened him to an untimely grave. Mr. Price, was at the time of his death in the sixty-first year of his age, and has left a wife, and a large family of children, to whom he was devotedly attached, to mourn the irreparable loss of a loving husband and kind father. May he who tempers the wind to the shorn lamb, guard and protect the disconsolate widow and fatherless children of our deceased friend, whose memory will ever be cherished by the members of this House, with whom he was so lately associated.

And may this sad bereavement have the effect of reminding each one of us that in the midst of life we are in death, and of the necessity of so ordering our conduct, that when we shall be called hence from our labors, we may be able to exclaim, we are ready to depart

for that land from which no traveler ever returns.

I move sir that a committee of five be appointed by the chair for the purpose of drafting resolutions suitable for the occasion to be presented to this House for its adoption, and that J. C. Hall of Des Moines, be Chairman of said Committee.

Mr. Clagett moved that a committee of five be appointed of

which Mr. Hall should be Chairman to prepare resolutions expressive of the sense of this House, upon the death of the Hon. C. J.

They have ten children -Mary, born in Pennsylvania, Jan. 11, 1837, the wife of Wm. Bronson, of Clark Co., Iowa; Sarah J., born in Pennsylvania, Nov. 8, 1838, the wife of Thos. Moore, of Montrose; Lucy Elizabeth, born in Pennsylvania, May 21, 1841, married James Thornton, a soldier in the late war, now deceased; Julia A., born in Pennsylvania, June 17, 1843, the wife of E. M. Stewart, of this county; John W., born in Pennsylvania, Oct. 30, 1845, of Idaho, engaged in freighting; Isaac N., born in Pennsylvania, Feb. 20, 1848, a resident of Henry Co., Iowa, a farmer; James H., born in Pennsylvania, Nov. 20, 1850, a farmer of this township; Christian G., born April 5, 1853, a farmer of this township; Lewis C., born in Lee Co., March 12, 1856; Ella, born in Lee Co., Oct. 9, 1860. Mr. Snook was formerly a member of the German Reformed Church. Has held various

township and school offices; is a Jackson Democrat.

STEPHENSON, JOHN S., far., Sec. 7; P.O. West Point; grandson of Edward Stephenson, who, in his early life settled at what is now the populous city of Cincinnati, Ohio, at that time consisting of a fort erected as a protection to the white settlers against the Indians; in that fort, John S., Sr., the father of John S., Jr., was born; during the year 1800, when but 4 or 5 years of age, his father died, soon after which his mother (the grandmother of John S., Jr.), returned to Wood Co., Va., their former home. Having reached manhood's estate, John S. soon returned to Hamilton Co., Ohio, thence to Dearborn Co., Ind., where he married Elizabeth Archibald, who was born near Boston, Mass., in 1801; they settled in Indiana, and after residing for a time in Hamilton Co., Ohio, in 1837, they became pioneers of Henry Co., Iowa., first settling in Baltimore Tp. for three years, thence to Jackson Tp., where, in 1846, he was elected to the State Legislature, and again in 1847; in 1855, he returned to Baltimore Tp., where, in 1865, he died; the mother is still a resident of that township; they had seven children, five sons and two daughters; John S., Jr., the youngest of the sons, was born in Hamilton Co., Ohio, in 1834, consequently being 3 years of age on the removal of his parents to Henry Co.; being 16 years of age before the erection of the first schoolhouse in his district; his means for education were somewhat limited; was employed on his father's farm until he reached the age of 26, when he married Annie E., daughter of Calvin J. Price, who was born in Smithfield, N. C., in 1801; afterward a resident of Tennessee; thence to Cairo, Ill., where he married Mary Conley, and in 1836 they were among the first settlers of West Point, this county, where he did the first mercantile business, and erected and kept the first hotel; during the first year of his

residence there his wife died, and in August, 1838, he married Frances Longford, born in Newcastle, Ky., in 1819, at that time a resident of Clarke Co., Mo. Mr. Price was a member of the first Territorial Legislature, and subsequently elected several times, and was a member of that honorable body at his death, which occurred in 1860. Price is now a resident of Lowell, Henry Co.; of seven children born of this marriage but four are now living, Mrs. Stephenson being the second born in Pleasant Ridge Tp., in 1841, and the only one of the family now residing in Lee Co.; soon after their marriage, they settled on the farm they now occupy, consisting of 168 acres of land, valued at \$50 per acre; they have four children-John C., born Jan. 23, 1863; Frances L., born Oct. 18, 1864; Edmund A., born Nov. 16, 1867, and Clyde L., born March 28, 1872. Democratic in politics; a member of Leaf Lodge, I. O. O. F., No. 57, at Lowell.

Sept. 6, 1855, he married Elizabeth, daughter of Valentine and Mary Woods, of that county, from Indiana; she was born in Ohio Co., Ind., in 1836; the fall after their marriage, they removed to Lee Co., and settled where he now resides, and owns 138 acres of land, valued at \$35 In 1864, his wife died, leavper acre. ing five children-Millard F., born Aug. 5, 1856; died at the age of 10; William M., born Jan. 6, 1858; Valentine C., born Aug. 2, 1859; Charles E., born March 12, 1861; Mary E., born Aug.

17, 1862. He then married Julia A. daughter of John C. Snook; she was born in Union Co., Penn., June 17. 1843; they have four children-John was born Aug. 5, 1867; Julia A., born Jan. 23, 1870; August J., born July 10. 1873; George A., born April 5, 1878. Mr. Stewart has served as Justice of the Peace for several years, and, in 1871. was elected to represent his county in the State Legislature.

Calvin Price Old Settler

LOWELL - After three generations the old Price homestead has passed into other hands. Several years ago it was modernized, and it is now occupied by Mr. and Mrs. Delbert Blindt and family.

The house was built by Calvin Price who, with his wife Frances Langford Price, and Mrs. Price's brother, John Langford, came to Iowa from Kentucky many years ago. The Langfords stopped at Kahoka, Mo., but Price had visions of a home on the great Iowa prairie. He acquired hundreds of acres of the rich prairie land, then considered worthless.

Price was active in early Iowa politics. He served in both the state senate and house of representatives when the capital was at Iowa City. His political career was ended by his death, which was the result of misplaced faith in a friend. This man had charge of state funds; Price vas his bondsman. The man embezzled the money and Price had to make it good. He returned from Iowa City broken in health and spirit, and soon after was buried in the Price cemetery.

Price had a son, Thomas Jefferson Price, who was then in his early teens. He took over management of the farm. The Civil War was in progress; from across the river at Croton the firing of cannon could be heard.

Jeff saddled a plow horse and, with his old Kentucky squirrel gun across his saddle, left for the meene of the action. A few days later he returned home - the Con**lederates** had retreated.

When T. J. Price died the old homestead passed to his son. Frank Price of Mount Pleasant. It left the Price family with the death of Frank Price.

As for John Langford, he remained at Kahoka, where he became a judge and a leading
