## HOUSE STUDY BILL COMMITTEE ASSIGNMENTS

**H.S.B. 111 Commerce, Regulation and Labor**

Relating to energy, by reassigning responsibilities of the energy bureau of the department of natural resources, and providing for ownership of alternate energy production facilities or small hydro facilities by public electric utilities.

**H.S.B. 112 Environmental Protection**

Relating to the review of subdivision plats by a local board of health or a county sanitarian.

**H.S.B. 113 State Government**

To establish an interior design examining board, to provide for the registration of interior designers in order to use the title of registered interior designer, and to provide fees and penalties.

**H.S.B. 114 State Government**

Providing for and requiring the statewide licensure of electricians and installers, providing for registration of apprentice electricians, establishing fees, providing penalties, and providing an effective date.

**H.S.B. 115 Ways and Means**

Relating to a sales tax exemption for supplies for machinery, equipment, and computers.

**H.S.B. 116 Ways and Means**

Relating to the phased-in reduction in the premiums tax rate for county and state mutual insurance associations.

**H.S.B. 117 Ways and Means**

Relating to the establishment of tax credits for income tax, franchise tax, premiums tax, and moneys and credits tax for businesses contributing to child care benefits for employees and including effective and applicability date provisions.

**H.S.B. 118 Ways and Means**

Relating to a community renewal initiative by establishing a community development program to provide tax credits for income tax, franchise tax, premiums tax, and moneys and credits tax for businesses contributing to community development projects to aid certain neighborhoods and communities and including effective and applicability date provisions.
