## JOURNAL OF THE HOUSE

Thirty-second Calendar Day - Twenty-third Session Day

Hall of the House of Representatives  
Des Moines, Iowa, Thursday, February 13, 2003

The House met pursuant to adjournment at 8:45 a.m., Speaker Rants in the chair.

Prayer was offered by Reverend Ron Riley, pastor of the Christian Church, Logan. He was the guest of Representative Paul Wilderdyke of Harrison County. Following the prayer, Rick Powell from Logan sang "I Pledge Allegiance to the Lamb".

### INTRODUCTION OF BILLS

[House Joint Resolution 3](#), by committee on state government, a joint resolution proposing an amendment to the Constitution of the State of Iowa relating to the qualification of electors.

Read first time and placed on the **calendar**.

[House File 190](#), by Foege and B. Hansen, a bill for an act relating to mandatory universal newborn and infant hearing screening.

Read first time and referred to committee on **human resources**.

[House File 191](#), by Jacobs, a bill for an act relating to Iowa individual income tax checkoffs, providing an income tax checkoff to fund child protection center grants, relating to the limitation on income tax checkoffs, making an appropriation, and including effective and applicability date provisions.

Read first time and referred to committee on **ways and means**.

[House File 192](#), by Klemme, a bill for an act prohibiting a cancellation penalty upon cancellation of a purchase agreement for cemetery merchandise, funeral merchandise, and funeral services.

Read first time and referred to committee on **commerce, regulation and labor**.

[House File 193](#), by Foege, a bill for an act creating a criminal offense for leaving an unattended or not properly supervised child in a motor vehicle, and providing a penalty.

HOUSE STUDY BILL COMMITTEE ASSIGNMENTS

**H.S.B. 136 Agriculture**

Providing for the administration of funds for animal agriculture, including moneys transferred from and deposited into these funds, and providing an effective date.

**H.S.B. 137 Economic Growth**

Relating to endow Iowa seed grants and endow Iowa tax credits and including effective and retroactive applicability dates.

**H.S.B. 138 Transportation**

Relating to snowmobile franchises by requiring the repurchase of certain inventory upon termination of a franchise.

**H.S.B. 139 Oversight**

Relating to government efficiency by providing for the delivery of administrative services to state government, establishment of common state services regional boundaries, revising medical assistance program eligibility and benefits provisions, improving coordination of veterans benefits eligibility determinations, requiring a comprehensive study of the state mental health institutes, and revising requirements involving the judicial district departments of correctional services, and providing effective dates.

**H.S.B. 140 Education**

Relating to personnel and instructors employed by community colleges.

**H.S.B. 141 Commerce, Regulation and Labor**

Establishing guidelines for a meatpacking industry workers' bill of rights.

**H.S.B. 142 Agriculture**

A concurrent resolution requesting that the United States Congress take all action required to preserve free and private enterprise, prevent monopoly, and protect consumers including by immediately enacting legislation to prohibit livestock packers from owning, controlling, or feeding livestock to such an extent that producers can no longer materially participate in the management of their livestock operations as provided in Senate Bill 27 introduced by the Honorable Senator Charles E. Grassley and cosponsored by the Honorable Senator Tom Harkin and others.

Fiscal Note is not required.

Recommended **Do Pass** February 13, 2003.

## COMMITTEE ON PUBLIC SAFETY

**Committee Bill** (Formerly [House Study Bill 91](#)), relating to intelligence data and intelligence assessment dissemination to an agency, organization, or person.

Fiscal Note is not required.

Recommended **Amend and Do Pass** February 13, 2003.

## COMMITTEE ON STATE GOVERNMENT

**Committee Bill** (Formerly [House Study Bill 18](#)), relating to massage therapy by providing for a study regarding the modalities associated with massage therapy and providing a temporary exemption from licensure requirements.

Fiscal Note is not required.

Recommended **Amend and Do Pass** February 13, 2003.
