HOUSE STUDY BILL COMMITTEE ASSIGNMENTS

[H.S.B. 665](#) **Transportation**

Relating to policies and duties of the state department of transportation, including placement of official signs on primary highways, inspection of bridges, administrative duties, motor vehicle registration and titling, driver licensing, licensing and regulation of

vehicle-related businesses, vehicle braking requirements, vehicle length restrictions, proof of financial responsibility requirements, and persons with disabilities parking permits.

H.S.B. 666 Judiciary

Relating to a request for certain health records by a party in a civil action where a party's health condition is an element or factor in the claim or defense of the action and providing for fees.

H.S.B. 667 Judiciary

Relating to statutory corrections which may adjust language to reflect current practices, insert earlier omissions, delete redundancies and inaccuracies, delete temporary language, resolve inconsistencies and conflicts, update ongoing provisions, or remove ambiguities, and including effective and retroactive applicability date provisions.

H.S.B. 668 Agriculture

Concerning wine, including the allowable alcohol content of wine and inspection of certain wine permittees.

H.S.B. 669 Commerce, Regulation and Labor

Relating to indemnity provisions in construction contracts.

H.S.B. 670 Commerce, Regulation and Labor

Relating to franchises for the provision of cable service or video service including providing for fees and providing an effective date.

H.S.B. 671 Commerce, Regulation and Labor

Relating to debt management, mortgage bankers and brokers, delayed deposit services, regulated loans, and industrial loans, and providing for fees and penalties.
