The House met pursuant to adjournment at 8:54 a.m., Gipp of Winneshiek in the chair.

Relating to the privacy of wireless communications service subscribers, including restrictions on the provision of wireless telephone number information, and providing penalties and remedies.

H.S.B. 674 Human Resources

Relating to medical malpractice actions.
