The House met pursuant to adjournment at 9:01 a.m., Tymeson of Madison in the chair.

Read first time and referred to committee on **state government**.

[House File 2521](#), by committee on appropriations, a bill for an act relating to and making appropriations to certain state departments, agencies, funds, and certain other entities, providing for regulatory authority, and other properly related matters and providing an effective date.

Read first time and placed on the **appropriations calendar**.

[House File 2522](#), by committee on judiciary, a bill for an act relating to the assessment of a fee when filing a praecipe.

Read first time and placed on the **calendar**.

[House File 2523](#), by committee on public safety, a bill for an act relating to safe motor vehicle operation, including penalties for

certain motor vehicle violations causing serious injury or death and classroom instruction for driver education courses.

Read first time and placed on the **calendar**.

[House File 2524](#), by committee on public safety, a bill for an act relating to the criminal offense of criminal trespass, and providing a penalty.

COMMITTEE ON AGRICULTURE

Committee Bill (Formerly [House File 2357](#)), relating to farm tenancies.

Fiscal Note is not required.

Committee Bill (Formerly [House File 2404](#)), relating to wine, including the allowable alcohol content of wine and inspection of certain wine permittees.

Committee Bill (Formerly [House File 2422](#)), relating to the delivery of E-85 gasoline to franchisees of motor fuel, and providing an effective date.

Committee Bill (Formerly [House Study Bill 662](#)), relating to devices used for weighing and measuring, by providing for the regulation of the devices, motor vehicle fuel, and persons who service the devices, and providing for fees and penalties.

COMMITTEE ON COMMERCE, REGULATION AND LABOR

Committee Bill (Formerly [House Study Bill 239](#)), relating to the laws administered by the labor commissioner, and to penalties assessed for violations of those laws, including regulation of safety inspection of amusement rides, and providing an effective date.

Fiscal Note is not required.

Recommended **Amend and Do Pass** February 23, 2006.

Committee Bill (Formerly [House Study Bill 544](#)), relating to the regulation of state banks and bank holding companies including the disclosure and release of regulatory information, attestation and publication requirements, the removal and service of officers, directors, and employees, and offers to purchase stock, and increasing civil penalties.

Fiscal Note is not required.

Recommended **Amend and Do Pass** February 23, 2006.

Committee Bill (Formerly [House Study Bill 660](#)), relating to the collection of liquidated debts owed to and various authorizations issued by the labor commissioner.

Fiscal Note is not required.

Recommended **Do Pass** February 23, 2006.

Committee Bill (Formerly [House Study Bill 671](#)), relating to debt management, mortgage bankers and brokers, delayed deposit services, regulated loans, and industrial loans, and providing for fees and penalties.

Fiscal Note is not required.

Recommended **Amend and Do Pass** February 23, 2006.

COMMITTEE ON JUDICIARY

Committee Bill (Formerly [House File 2286](#)), creating the penalty of death for the commission of murder in the first degree, kidnapping, and sexual abuse against the same minor, using DNA or fingerprint evidence to identify the perpetrator, providing a penalty, and providing an effective date.

Fiscal Note is not required.

Recommended **Do Pass** February 23, 2006.

COMMITTEE ON NATURAL RESOURCES

Committee Bill (Formerly [House File 453](#)), relating to trespassing, including the authority of the department of natural resources to suspend or revoke hunting, fishing, or trapping licenses for trespass violations, and providing penalties.

Fiscal Note is not required.

Recommended **Amend and Do Pass** February 22, 2006.
