ADOPTION OF [HOUSE RESOLUTION 114](#)

Upmeyer of Cerro Gordo called up for consideration [House Resolution 114](#), a resolution reaffirming Iowa's commitment to its relationship with Taiwan, particularly to strengthening sister-state ties and continuing to grow trade and exchanges between Iowa and Taiwan; reaffirming support for Taiwan's efforts to secure entry to the Trans-Pacific Partnership; and supporting the signing of a bilateral investment agreement between Taiwan and the United States, and moved its adoption.

The motion prevailed and the resolution was adopted.
