The House met pursuant to adjournment at 8:32 a.m., Speaker Paulsen in the chair.

SENATE MESSAGE CONSIDERED

Read a first time and **passed on file**.

The House resumed session at 9:04 a.m., Speaker Paulsen in the chair.

ADOPTION OF [HOUSE RESOLUTION 108](#)

Upmeyer of Cerro Gordo called up for consideration [House Resolution 108](#), a resolution commemorating the members of the United States Cadet Nurse Corps, and moved its adoption.

The motion prevailed and the resolution was adopted.

On motion by Upmeyer of Cerro Gordo, the House was recessed at 9:07 a.m., until 3:00 p.m.
