#### **MEMORANDUM**

RE: Department of Corrections Lease-Purchase Notification

The Legislative Services Agency (LSA) received a lease-purchase notification from the Department of Corrections (DOC) on June 24, 2019, for the purchase of Sophos firewall hardware and software licensing that controls all Internet traffic. The agreement includes antivirus software licensing on all DOC workstations and servers. The DOC has used Sophos for the past three years and over that time period, the Department indicates that the number of compromised systems has been cut in half. All Sophos licenses currently in place will expire June 30, 2019.

The estimated cost of the lease-purchase is \$336,900, including \$328,700 in principal and \$8,200 in interest. The agreement will be for a period of three years at an estimated interest rate of 2.53%. The annual debt service payments are estimated to total \$112,300. The Department will use State General Fund dollars to fund the lease-purchase.

The attachment provides additional information regarding the lease-purchase.

This notice is for information purposes only and no action is required on behalf of the Legislative Fiscal Committee. Iowa Code section <u>8.46</u> requires State agencies proposing to enter into a lease-purchase agreement of at least \$50,000 to notify the LSA at least 30 days prior to entering into a contract.
