Estimates reflect school aid provisions approved by the General Assembly for FY 2015, including an modifications to the shared operational functions supplementary weighting in HF 2271 (and updated based on new data from 4/25/2014) and an additional AEA reduction of \$15.0 million.

*Estimates include the provision that provides property tax relief for any increase resulting in the per pupil increase funded with property tax is to be funded with State aid.

**Amount includes PTER Funds used for property tax relief.

Budget guarantee amounts provided are included in the total foundation property tax amounts displayed.

GF = General Fund

PTER = Property Tax Equity and Relief Fund

Combined district cost represents the total school foundation funding amount and is not impacted by a reduction in State school aid.

***Provides one-time State aid based on 2.0% of the FY 2013 regular program State cost per pupil multiplied by each district's budget enrollment.

C/I (Commercial and Industrial) rollback replacement payment represents the estimated portion for the uniform levy and additional levy. The total adjusted foundation property tax has been reduced by the estimated C/I rollback replacement payment.

Estimates are not official or final. The Department of Management will provide the official school aid amounts.
