MANUFACTURED OR MOBILE HOME HOOKUPS. A licensed 7 manufactured or mobile home retailer or an employee of a 8 licensed manufactured or mobile home retailer may perform water, gas, electrical, and other utility service connections 4 10 in a manufactured or mobile home space, or within ten feet of 4 11 such space, located in a manufactured home community or mobile 4 12 home park. The licensed retailer or an employee of the 4 13 retailer is not required to obtain any additional state or 4 14 local authorization, permit, or license to perform utility 4 15 service connections. However, the utility service connections 4 16 are subject to inspection and approval by the local building 4 17 department and the manufactured or mobile home retailer shall 4 18 pay the inspection fee, if any.

Sec. 3. <u>NEW SECTION</u>. 103A.53 LICENSE APPLICATION AND 20 FEES.

Upon application and payment of a one hundred dollar fee, a 22 person may be licensed as a manufacturer or distributor of 23 manufactured or mobile homes.
