House File 2202

AN ACT

RELATING TO CONTROLLED SUBSTANCES SCHEDULES AND PRECURSOR
SUBSTANCES REPORTING REQUIREMENTS, MAKING PENALTIES
APPLICABLE, AND INCLUDING EFFECTIVE DATE PROVISIONS.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF IOWA:

Section 1. Section 124.204, subsection 2, Code 2026, is amended by adding the following new paragraphs:

NEW PARAGRAPH. *dd.* 2-(2-(4-butoxybenzyl)-5-nitro-1H-benzimidazol-1-yl)-N,N-diethylethan-1-amine. Other name: Butonitazene.

NEW PARAGRAPH. *de.* N,N-diethyl-2-(2-(4-fluorobenzyl)-5-nitro-1H-benzimidazol-1-yl)ethan-1-amine. Other name: Flunitazene.

NEW PARAGRAPH. *df.* N,N-diethyl-2-(2-(4-methoxybenzyl)-1H-benzimidazol-1-yl)ethan-1-amine. Other name: Metodesnitazene.

NEW PARAGRAPH. *dg.* N-phenyl-N-(1-(2-phenylpropyl)piperidin-4-yl)acetamide. Other name: beta-methylacetyl fentanyl.

NEW PARAGRAPH. *dh.* N-(3-fluorophenyl)-N-(1-phenethylpiperidin-4-yl)furan-20carboxamide. Other name: meta-fluorofuranyl fentanyl.

NEW PARAGRAPH. *di.* N-(2-chlorophenyl)-N-(1-phenethylpiperidin-4-yl)propionamide. Other name: ortho-chlorofentanyl.

NEW PARAGRAPH. *dj.* N-(2-methylphenyl)-N-(1-phenethylpiperidin-4-yl)cyclopropanecarboxamide. Other name: ortho-methylcyclopropyl fentanyl.

NEW PARAGRAPH. *dk.* N-(4-chlorophenyl)-N-(1-phenethylpiperidin-4-yl)propionamide. Other name: para-chlorofentanyl.

NEW PARAGRAPH. *dl.* N-(4-fluorophenyl)-N-(1-phenethylpiperidin-4-yl)pentanamide. Other name: para-fluoro valeryl fentanyl.

NEW PARAGRAPH. *dm.* N-(1-phenethylpiperidin-4-yl)-N-phenyltetrahydrothiophene-2-carboxamide. Other names: tetrahydrothiofuranyl fentanyl; tetrahydrothiophene fentanyl.

Sec. 2. Section 124.204, subsection 4, Code 2026, is amended by adding the following new paragraph:

NEW PARAGRAPH. *cq.* 1-(1,3-benzodioxol-5-yl)-2-(dimethylamino)pentan-1-one. Other names: dipentylone; N,N-dimethylpentylone.

Sec. 3. Section 124.204, subsection 6, Code 2026, is amended by adding the following new paragraph:

NEW PARAGRAPH. *m.* ethyl 2-phenyl-2-(piperidin-2-yl)acetate. Other name: ethylphenidate.

Sec. 4. Section 124.204, subsection 9, Code 2026, is amended by adding the following new paragraphs:

NEW PARAGRAPH. *w.* 2-(4-methoxybenzyl)-5-nitro-1-(2-(pyrrolidin-1-yl)ethyl)-1H-benzimidazole, its isomers, esters, ethers, salts, and salts of isomers, esters, and ethers. Other names: N-pyrrolidino metonitazene; metonitazepyne.

NEW PARAGRAPH. *x.* 5-nitro-2-(4-propoxybenzyl)-1-(2-(pyrrolidin-1-yl)ethyl)-1H-benzimidazole, its isomers, esters, ethers, salts, and salts of isomers, esters, and ethers. Other names: N-pyrrolidino protonitazene; protonitazepyne.

Sec. 5. Section 124.204, subsection 9, paragraphs c, e, and f, Code 2026, are amended by striking the paragraphs.

Sec. 6. EFFECTIVE DATE. This Act, being deemed of immediate

importance, takes effect upon enactment.
