A BILL FOR

An Act relating to the salary of the clerk of the grand jury in counties having a population of over one hundred fifty thousand (150,000).

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Section seven hundred seventy point twenty-one
- 2 (770.21), Code 1958, as amended by chapter three hundred
- 3 seventy-five (375), Acts of the Fifty-eighth General Assembly,
- 4 is hereby amended by striking the last paragraph of said
- 5 section and inserting in lieu thereof the following:
- 6 "In counties having a population of one hundred fifty
- 7 thousand (150,000) and over, such clerks shall receive an
- 8 annual salary of six thousand dollars (\$6,000)."

EXPLANATION OF HOUSE FILE 146

The purpose of this bill is to increase the salary of grand jury clerks in counties having a population of over 150,000 from \$5,400 to \$6,000.

HOUSE FILE 146

- 1 Amend House File 146 as follows:
- 2 1. Amend line 4 by striking the words "last
- 3 paragraph" and inserting in lieu thereof the words,
- 4 "last three paragraphs".
- 5 2. Strike all after the word "following:" in line 5
- 6 and insert in lieu thereof the following:
- 7 "In all counties having a population of more than
- 8 seventy-five thousand (75,000) inhabitants and less
- 9 than one hundred-twenty thousand (120,000) such, each
- 10 clerk shall receive as compensation an annual salary
- 11 of not to exceed three thousand dollars (\$3,000).
- 12 In counties having a population of one hundred-twenty
- 13 thousand (120,000) and over and less than one hundred-
- 14 fifty thousand (150,000) inhabitants, each clerk shall
- 15 receive an annual salary of forty-four hundred dollars
- 16 (\$4,400). In counties having a population of one hundred-
- 17 fifty thousand (150,000) and over, such clerks shall
- 18 receive an annual salary of six thousand dollars (\$6,000)."
