A BILL FOR

An Act to amend certain sections of the Code 1958, relating to special limitations of actions in regard to the recovery of interests in real estate.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Section six hundred fourteen point fourteen
- 2 (614.14), Code 1958, is amended by striking from line eight (8)
- 3 the figures "1940" and inserting in lieu thereof the following,
- 4 "1950".
- 5 Further amend said section by striking from the last line the
- 6 figures "1952" and inserting in lieu thereof the following,
- 7 "1962".
- 1 Sec. 2. Section six hundred fourteen point fifteen (614.15),
- 2 Code 1958, is amended as follows:
- 3 1. Strike from line three (3) the figures "1940" and insert
- 4 in lieu thereof the figures "1950";
- 5 2. Strike from line eleven (11) the figures "1951" and
- 6 insert in lieu thereof the following, "1961";
- 7 3. Strike from line twenty (20) the figures "1951" and
- 8 insert in lieu thereof the following, "1961".
- 1 Sec. 3. Section six hundred fourteen point sixteen (614.16),
- 2 Code 1958, is amended by striking from line seven (7) the
- 3 figures "1951" and inserting the figures, "1961" in lieu thereof.
- 1 Sec. 4. Section six hundred fourteen point seventeen (614.17),
- 2 Code 1958, is amended by striking from lines two (2) and eleven

3 (11) the figures "1940" and inserting in each instance the
4 figures "1950" in lieu thereof.

5 Further amend said section by striking from line sixteen (16)
6 the figures "1951" and inserting the figures "1961" in lieu
7 thereof.

8 Further amend said section by striking from the last line
9 thereof the figures "1951" and inserting the figures "1961" in
10 lieu thereof.

1 Sec. 5. Section six hundred fourteen point twenty (614.20),
2 Code 1958, is amended by striking from line nineteen (19) the
3 figures "1951" and inserting in lieu thereof the following,
4 "1961".

1 Sec. 6. Section six hundred fourteen point twenty-two
2 (614.22), Code 1958, is amended by striking from line ten (10)
3 the figures "1940" and inserting the figures "1950" in lieu
4 thereof.

5 Further amend said section by striking from lines twelve (12)
6 and fifteen (15) the figures "1953" and inserting the figures
7 "1963" in lieu thereof.

8 Further amend said section by striking from line twenty-five
9 (25) the figures "1951" and inserting the figures "1961" in
10 lieu thereof.

EXPLANATION OF HOUSE FILE 235

This bill amends certain sections of the Code 1958, relating to special limitations of actions in regard to the recovery of interests in real estate. These sections are due to be up-dated every ten years. See sections 614.14, 614.15, 614.16, 614.17, 614.20, and 614.22, Code of Iowa

HOUSE FILE 235

1 Amend House File 235 by adding a new section as follows:
2 Sec. 7. Nothing in this Act shall be construed to revive
3 any cause of action, previously barred by the provisions of
4 sections herein amended, prior to the effective date of this
5 Act.
