## A BILL FOR

An Act to make appropriations to members of the committee on public assistance study, namely: Jake B. Mincks, Jack Schroeder, Walter Edelen, Guy G. Butler, J. Louis Fisher, George E. O'Malley, Riley Dietz, Robert Fulton, Kenneth Owen, Hillman H. Sersland, A. L. Mensing and Robert Dodds.

Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated out of the  
2 general fund of the state of Iowa to the following-named  
3 persons the amounts set opposite their respective names  
4 in full settlement of all claims which they may have  
5 against the state of Iowa on account of services rendered  
6 as a member of the committee on public assistance study,  
7 to wit:

1 Section 2. The state comptroller is hereby authorized  
2 to issue his warrants to the above-named parties in the  
3 amounts stated, and the treasurer is hereby directed to  
4 pay the same from the funds herein appropriated.

1 Sec. 3. The acceptance of said sums by the above-  
2 named parties shall be in full settlement of all claims  
3 against the state of Iowa growing out of the above-  
4 described claims.

1 Sec. 4. This Act being deemed of immediate importance  
2 shall take effect and be in full force from and after its  
3 publication in the ....., a newspaper published  
4 at ....., Iowa, and the ....., a newspaper  
5 published at ....., Iowa.
