A BILL FOR

An Act relating to removal of members of county conservation boards.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Section one hundred eleven A point two (111A.2),
- 2 Code 1958, is hereby amended by adding thereto the following:
- 3 "Members of the county conservation board may be removed by the
- 4 body making such appointment, but every such removal shall be by
- 5 written order, which shall be filed with the county auditor."

EXPLANATION OF HOUSE FILE 435

The power of removing appointive officials is a long-delegated power to cities and towns. This merely extends to the county board of supervisors so that they can remove an appointee.

HOUSE FILE 435

- 1 Amend House File 435 by adding the following new section:
- 2 Sec. 2. Chapter one hundred eleven A (111A), Code 1958,
- 3 is hereby amended by adding thereto the following:
- 4 "Whenever a county conservation board has been created by
- 5 an election as herein provided it may be abolished by petition
- 6 and election in the same manner in which it was created. A
- 7 notice shall be published once each week for two (2) consecutive
- 8 weeks preceding the date of said election in a newspaper in and
- 9 having general circulation in such county. In the event there
- 10 is no newspaper published in such county publication may be
- 11 made in any newspaper having general circulation in the county."

- 7 board made pursuant to and in compliance with all of the
- 8 provisions of chapter twenty-four (24) of the Code,".
- 9 Further amend said section by inserting immediately
- 10 following the word "purposes." in line twenty-seven (27)
- 11 of said section the words "Any single expenditure of, or
- 12 contract to expend a sum in excess of two thousand dollars
- 13 shall be subject to the provisions of chapter twenty-three
- 14 (23) of the Code".
