EXPLANATION OF HOUSE FILE 461

While the cost of living index in this country has risen to a new high the salaries received by elected county officers in Iowa are far below those paid to other public officers who hold like positions with equal responsibilities and qualifications.

Salaries paid to officers who hold such like positions, but who are appointed by taxing and governing bodies, are much greater than salaries received by elective county officials, and this measure will tend to bring salaries for all officers on the county level, appointive or elective, to a more equal status.
