An Act relating to commerce commission fees of motor vehicle
common and contract carriers.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section three hundred twenty-seven point nine
2 (327.9), Code 1958, as amended, is hereby amended by striking the
3 first five (5) lines thereof and inserting in lieu thereof the
4 following:

5 "No motor truck engaged in the transportation of property
6 under a truck operator or contract carrier permit issued under
7 the provisions of this chapter shall be operated on the highways
8 of this state unless there shall have been paid to the commission
9 for the administration of this chapter an annual fee".

1 Sec. 2. Section three hundred twenty-seven point nine
2 (327.9), Code 1958, as amended, is hereby further amended by
3 adding thereto the following:

4 "It shall be a misdemeanor for any truck operator or
5 contract carrier to operate any motor truck for which the annual
6 fee of five dollars (\$5) has not been paid and the commission may
7 revoke the truck operator and/or contract carrier permit of any
8 such violator."

1 Sec. 3. Section three hundred twenty-five point thirty-five
2 (325.35), Code 1958, as amended, is hereby amended by striking
3 all of the section preceding the word "in" in line seven (7)

4 thereof and inserting in lieu thereof the following:

5 "No motor vehicle engaged in the transportation of property
6 under a certificate of convenience and necessity issued under the
7 provisions of this chapter shall be operated on the highways of
8 this state unless there shall have been paid to the commission
9 for the administration of this chapter an annual fee".

1 Sec. 4. Section three hundred twenty-five point thirty-five
2 (325.35), Code 1958, as amended, is hereby further amended by
3 adding thereto the following:

4 "It shall be a misdemeanor for any motor carrier to operate
5 any motor vehicle for which the annual fee of five dollars (\$5)
6 has not been paid and the commission may revoke the certificate
7 of convenience and necessity of any such violator."

EXPLANATION OF HOUSE FILE 565

This bill relates the fees to be paid on vehicles operated by motor vehicle common carriers and contract carriers to the vehicle rather than to the certificate or permit of authority.

HOUSE FILE 565

- 1 Amend House File 565, section four (4), by inserting in
- 2 line four (4) after the word "misdemeanor" the following:
- 3 "punishable by a fine of not to exceed one hundred dollars
- 4 or by imprisonment in the county jail not to exceed thirty
- 5 days."
