## A BILL FOR

An Act to legalize and validate the special election of the Lake Township School District, Pottawattamie County, Iowa, held on June 8, 1960, for the issuance of \$49,000.00 of school bonds.

WHEREAS, on the 10th day of May, 1960, the Board of directors of the Lake Township School District, Pottawattamie County, Iowa, pursuant to a petition filed by certain voters of said school district, called a special election of the voters of said school district for June 8, 1960, on the question of the issuance of school bonds by said district in the sum of \$49,000.00 for the purpose of building and equipping a schoolhouse within said district; and

WHEREAS, at said election said proposition was approved by more than sixty percent of the total votes cast for or against said proposition, there being 116 votes cast in favor of said proposition and 8 votes against the same; and

WHEREAS, doubts have arisen concerning the validity and legal sufficiency of said election and it is advisable to put such doubts and all other doubts that might arise concerning such election forever at rest; now therefore,

*Be It Enacted by the General Assembly of the State of Iowa:*

- 1 Section 1. All proceedings heretofore taken by the
- 2 Board of Directors of the Lake Township School District,
- 3 Pottawattamie County, Iowa, preliminary to and in connection
- 4 with the call of the special election held on June 8, 1960
- 5 for the submission of the proposition of the issuance of
- 6 \$49,000.00 school bonds for the purpose of building and
- 7 equipping a schoolhouse within said district, including also
- 8 the petition for the calling of the election, the notice
- 9 of election, the election ballot, the election itself and the
- 10 adoption of said proposition at said election by the voters

11 of said school district, are hereby legalized, validated  
12 and confirmed, and shall constitute full authority for the  
13 board of directors of said school district to issue said  
14 bonds for the aforesaid proposition authorized at said  
15 election, in the amount of not to exceed \$49,000.00 and  
16 said bonds, when issued, shall constitute valid and binding  
17 obligations of said school district.

1 Sec. 2. This Act being deemed of immediate importance  
2 shall be in full force and effect from and after its  
3 passage and publication in the Neola Gazette-Reporter, a  
4 newspaper published at Neola, Iowa, and in The Casey  
5 Vindicator, a newspaper published at Casey, Iowa, all  
6 without expense to the state of Iowa.
