A BILL FOR

An Act to amend chapter two hundred seventy-nine (279), Code 1958, by adding thereto a new section to provide for use of funds received from sale, condemnation or other disposition of schools or sites without a vote of the electorate in school districts located in whole or in part within cities having a population of more than one hundred twenty-five thousand (125,000).

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Chapter two hundred seventy-nine (279), Code
 2 1958, is amended by adding thereto the following new section:
 3 "In school districts located in whole or in part within
 4 cities having a population of more than one hundred twenty-five
 5 thousand (125,000), any funds derived from the condemnation,
 6 sale, or other disposition for public purposes of school houses,
 7 school sites or both school houses and school sites may be
 8 deposited in the school house fund and may without a vote of
 9 the electorate be used for the purchase of school sites and/or
 10 the erection or repair of school houses as ordered by the board
 11 of directors of such school district, provided, however, that
 12 the board shall comply with section two hundred ninety-seven
 13 point seven (297.7), Code 1958."
