*Be It Enacted by the General Assembly of the State of Iowa:*

- 1 Section 1. Section three hundred sixty-eight-A point
- 2 three (368A.3), Code 1958, is amended by adding at the end of
- 3 subsection three (3) the following: "The provisions of this
- 4 subsection shall be fully applicable in towns in which a
- 5 newspaper is published but in all other towns the posting
- 6 of such statement in three (3) public places shall be sufficient
- 7 compliance herewith."
