- 3 is amended by striking all of lines four (4) through eight (8)
- 4 and by inserting in lieu thereof the following:
- 5 "The annual salary of each municipal judge shall be
- 6 eighty (80) per cent of the maximum salary set by statute for
- 7 judges of the district courts."
