## A BILL FOR

An Act to amend chapter six hundred five A (605A), Code 1958, making certain changes in the judicial retirement system, including the amount of the annuity that the judge shall receive upon retirement.

*Be It Enacted by the General Assembly of the State of Iowa:*

- 1 Section 1. Section six hundred five A point seven (605A.7),
- 2 Code 1958, as amended, is hereby repealed and the following
- 3 adopted in lieu thereof:
- 4 "Amount of Annuity. The annuity of a judge under this
- 5 system shall be an amount equal to three (3) percent of his
- 6 salary at the time of retirement as a judge of the supreme,
- 7 district, superior or municipal court, multiplied by his years
- 8 of service in one or more of said courts, but no such annuity
- 9 shall exceed an amount equal to sixty (60) percent of his
- 10 salary at the time he becomes separated from such service."

16 the word "four" and substituting therefor the word "five".

17 Sec. 2. Section six hundred five A point seven (605A.7),  
18 Code 1958, is hereby amended as follows:

19 1. By striking from line three (3) thereof the word "two"  
20 and substituting therefor the word "three".

21 2. By striking from line eight (8) thereof the word  
22 "forty" and substituting therefor the word "fifty".

23 Sec. 3. Amend the title by inserting after the comma  
24 in line one (1) the words "and chapter three hundred fifty-  
25 six (356), Acts of the Fifty-eighth General Assembly".
