## A BILL FOR

An Act relating to the Iowa national guard and the Iowa air national guard and to amend various sections of the Code relating thereto.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. Section twenty-nine point fifteen (29.15), Code  
2 1958, is hereby amended by inserting in line six (6) after the  
3 word "badges" the words "or other appropriate awards".

1 Sec. 2. Section twenty-nine point twenty-seven (29.27),  
2 Code 1958, is hereby amended by striking in line nine (9) the  
3 word "three" and inserting in lieu thereof the word "five (5)".

1 Sec. 3. Section twenty-nine point fifty-four (29.54), Code  
2 1958, is hereby repealed and the following enacted in lieu  
3 thereof:

4 "The senior line commander of troops of the Iowa national  
5 guard, the senior air commander of the Iowa air national guard,  
6 and the adjutant general of Iowa, shall receive annual expense  
7 allowance in the sum of two thousand five hundred (2,500)  
8 dollars, payable each calendar year in such sums and at such  
9 times as said individuals may request. However, no payment  
10 shall be made during such time as the Iowa national guard or  
11 the Iowa air national guard are in federal service."

1 Sec. 4. Section twenty-nine point fifty-seven (29.57),  
2 Code 1958, is hereby amended as follows:

3 1. By striking from line twenty-two (22) the word "armories"

4 and inserting in lieu thereof the words "installations and  
5 facilities of the Iowa national guard and the Iowa air national  
6 guard".

7 2. By striking from line fifty-one (51) the word "armory"  
8 and inserting in lieu thereof the words "installation and  
9 facility".

10 3. By striking from line fifty-five (55) the words "armory  
11 purposes" and inserting in lieu thereof the words "installations  
12 and facilities".

13 4. By striking from line seventy-five (75) the word  
14 "regiment" and inserting in lieu thereof the words "battle  
15 group".

1 Sec. 5. Section twenty-nine point fifty-eight (29.58),  
2 Code 1958, is hereby amended by adding to the last paragraph  
3 the following:

4 "Payments of special tax assessments arising under the lease  
5 may be paid from funds appropriated for the support and  
6 maintenance of the national guard."

EXPLANATION OF SENATE FILE 35

The bill makes certain amendments to chapter 29 of the 1958 Code. Certain technical corrections are made such as changing the word "armory" to the words "installation and facility" and changing the word "regiment" to the words "battle group." The bill also increases annual expense allowances for certain officers, increases the pay of enlisted men when in training, and provides that special tax assessments arising under certain leases may be paid from funds appropriated for the support and maintenance of the national guard.
