A BILL FOR

An Act relating to the recording of instruments.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section three hundred thirty-five point fourteen
2 (335.14), Code 1958, is hereby amended as follows:
3 1. By striking from lines one (1) and two (2) of sub-
4 section one (1) the words "containing four hundred words or less,
5 one dollar" and inserting in lieu thereof, the words "one dollar
6 and fifty cents for the first page or fraction thereof".
7 2. By striking all of subsection two (2) and the amendment
8 by section two (2) of Chapter two hundred fifty-five (255), Acts
9 of the Fifty-eighth General Assembly, and inserting in lieu thereof
10 the following, "For each additional page or fraction thereof,
11 one dollar."

12 3. By adding a subsection as follows: "The minimum fee
13 for all deeds and real property mortgages shall be two dollars."

1 Sec. 2. Section five hundred fifty-six point twenty (556.20),
2 Code 1958, is amended by deleting in subsection two (2) the words,
3 "one dollar for the first four hundred words and twenty cents for
4 each one hundred additional words or fraction thereof." and in-
5 serting in lieu thereof the words "one dollar and fifty cents for
6 the first page or fraction thereof and one dollar for each addi-
7 tional page or fraction thereof."
