A BILL FOR

An Act to appropriate funds from the Iowa Public Employees' Retirement Fund to the employment security commission as a proportionate share in the cost of erecting an administrative building for the use of the commission.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated from the Iowa
2 Public Employees' Retirement Fund to the employment
3 security commission the sum of two hundred twenty-five
4 thousand dollars (\$225,000.00) or so much thereof as may
5 be necessary, to be used for a proportionate share in the
6 cost of erecting a building for the use of the employment
7 security commission in its administration of chapters
8 ninety-six (96), ninety-seven B (97B), and ninety-seven C
9 (97C), Code 1958.

1 Sec. 2. Any unobligated balance of funds herein
2 appropriated as of June 30, 1963, shall revert to the
3 Iowa Public Employees' Retirement Fund.

1 Sec. 3. This Act being deemed of immediate importance
2 shall be in full force and effect from and after its
