A BILL FOR

An Act to appropriate money credited to the account of the state of Iowa in the unemployment trust fund pursuant to section nine hundred three (903) of the Social Security Act.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated out of the
2 funds made available to this state under section nine
3 hundred three (903) of the Social Security Act, as amended,
4 the sum of one million four hundred six thousand four
5 hundred forty-two dollars and forty-three cents (\$1,406,442.43),
6 or so much thereof as may be necessary, to be used, under
7 the direction of the Iowa employment security commission,
8 subject to the approval of the executive council of the
9 state, for the purpose of acquiring land and the purchase
10 or the erection of a building or buildings thereon, and
11 for such improvements, facilities, paving, landscaping,
12 furnishings and fixed equipment as may be required for
13 the use of the Iowa employment security commission in the
14 performance of its functions under chapter ninety-six (96),
15 Code 1958.

1 Sec. 2. The money hereby appropriated shall be
2 requisitioned, only in amounts necessary to meet current
3 obligations, by the Iowa employment security commission
4 from the unemployment trust fund maintained by the

5 secretary of the United States department of the treasury
6 and deposited in the employment security administration
7 fund in accordance with the provisions of section ninety-
8 six point nine (96.9), Code 1958, as amended, but shall
9 remain a part of the unemployment fund until expended.

1 Sec. 3. No part of the money hereby appropriated may
2 be obligated after the expiration of the two (2) year
3 period beginning with the date of enactment of this Act.

1 Sec. 4. The amount obligated pursuant to this Act
2 during any 12-month period beginning on July 1 and ending
3 on the next June 30 shall not exceed the amount by which
4 (a) the aggregate of the amounts credited to the account
5 of this state pursuant to section nine hundred three (903)
6 of the Social Security Act during such 12-month period and
7 the four (4) preceding 12-month periods exceeds (b) the
8 aggregate of the amounts obligated for administration and
9 paid out for benefits and charged against the amounts
10 credited to the account of this state during such five (5)
11 12-month periods.

1 Sec. 5. This Act being deemed of immediate importance
2 shall take effect and be in full force from and after its
3 passage and publication in the
