A BILL FOR

An Act relating to miscellaneous fees collected by county recorders.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section one hundred ten point four (110.4),
2 Code 1958, is amended by striking the word "Depositaries" from
3 line nine (9) and striking all of lines ten (10) to fourteen
4 (14), both inclusive, and inserting in lieu thereof, the
5 following: "All depositaries and county recorders shall
6 charge an issuing fee of fifteen (15) cents for resident
7 licenses and twenty-five (25) cents for nonresident licenses
8 for the service rendered in issuing licenses. Said issuing
9 fee collected by the recorder shall be accounted for as regular
10 county fees."

1 Sec. 2. Section five hundred forty-seven point three
2 (547.3), Code 1958, is amended by striking from line three (3),
3 the words "one dollar" and inserting in lieu thereof the words
4 "two (2) dollars".

1 Sec. 3. Section five hundred fifty-six point twenty
2 (556.20), Code 1958, is amended by striking from line three (3)
3 in subsection one (1) the words "fifty cents" and inserting in
4 lieu thereof, the words "one (1) dollar".
