A BILL FOR

An Act to amend chapter two hundred seventy-four (274),
Code 1958, relative to school districts.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Chapter two hundred seventy-four (274),

2 Code 1958, is hereby amended by adding the following new
3 sections:

4 1. "The boundary lines of contiguous school corporations
5 may be changed by the concurrent action of the respective
6 boards of directors at their regular meetings in July, or at
7 special meetings called for that purpose. The
8 corporation from which territory is detached shall, after
9 the change, contain not less than four (4) government
10 sections of land."

11 2. "Any school board may request a study and
12 recommendations of the state board of public instruction
13 relative to the adjustment of boundary lines and the
14 recommendations of the state board of public instruction
15 shall be submitted to those districts involved within sixty
16 (60) days after the request for such study and recommendations
17 is made but such recommendations shall be advisory only and
18 shall not be binding on the local districts."

1 Sec. 2. This act being deemed of immediate importance
2 shall take effect and be in force from and after its

- 4 published in Clinton, Iowa and The Cedar Rapids Gazette,
- 5 a newspaper published in Cedar Rapids, Iowa.
