## A BILL FOR

An Act relating to the state senatorial districts.

*Be It Enacted by the General Assembly of the State of Iowa:*

- 1 Section 1. Section forty-one point one (41.1), Code 1958,
- 2 is hereby repealed and the following enacted in lieu thereof:
- 3 The number of senators in the general assembly is hereby
- 4 fixed at fifty, and they are hereby apportioned among the
- 5 several counties according to the number of inhabitants in each,
- 6 and under said apportionment the state is hereby divided into
- 7 fifty senatorial districts, each district to have one senator,
- 8 as follows:
- 9 1. Lee county shall constitute the first district.
- 10 2. Appanoose county, Davis county and Van Buren county shall
- 11 constitute the second district.
- 12 3. Lucas county, Monroe county and Wayne county shall
- 13 constitute the third district.

- 16 5. Adams county, Montgomery county and Taylor county shall
- 17 constitute the fifth district.

25 In all other senatorial districts the Act shall be effective  
26 as to the nomination and election of senators for full four-year  
27 terms in the year 1964, except that in the nineteenth (19th),  
28 twenty-sixth (26th) and forty-third (43rd) districts senators  
29 shall be elected for two-year terms.

30 This Act shall not affect the terms of office of senators  
31 now holding certificates of election from the present senatorial  
32 districts. In the event of any vacancy occurring in any  
33 senatorial district after July 4, 1961 it shall be filled by  
34 the electors of the district as it existed at the time the  
35 vacancy occurred. For the legislative session in 1963 and at  
36 any special session thereafter prior to 1965 the following  
37 counties are hereby attached for the purpose of representation  
38 in the senate to the present districts designated opposite the  
39 name of the county:

- 41 Muscatine to the twenty-third
