## A BILL FOR

An Act to accept the National Defense Education Act of 1958 and to make an appropriation from the general fund of the state of Iowa to the department of public instruction for participation in said Act.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. The provisions of the Act of Congress entitled  
2 "National Defense Education Act of 1958", approved September 2,  
3 1958, (P. L. 864, 85th Congress) and all amendments thereto and  
4 the benefit of all funds appropriated under said Act are accepted.

1 Sec. 2. There is hereby appropriated from the general fund of  
2 the state of Iowa to the department of public instruction for  
3 each year of the biennium beginning July 1, 1961, and ending  
4 June 30, 1963, the sum of sixty-five thousand two hundred fifty  
5 dollars (\$65,250.00), or so much thereof as may be necessary, to  
6 be used in the following manner:

7 For the administration and extension of supervisory and  
8 related services by the department of Title III, financial  
9 assistance for strengthening science, mathematics and modern  
10 foreign language instruction .....\$ 65,250.00

1 Sec. 3. There is hereby appropriated from the general fund of  
2 the state of Iowa to the department of public instruction for  
3 each year of the biennium beginning July 1, 1961, and ending June  
4 30, 1963, the sum of two hundred fifty thousand dollars  
5 (\$250,000.00), or so much thereof as may be necessary, to be

6 used in the following manner:

7 For the administration by the department and for use by  
 8 the several school districts of the state for Title VIII, area  
 9 vocational programs.....\$ 250,000.00

1 Sec. 4. There is hereby appropriated from the general fund  
 2 of the state of Iowa to the department of public instruction  
 3 for each year of the biennium beginning July 1, 1964, and  
 4 ending June 30, 1963, the sum of sixty-five thousand dollars  
 5 (\$65,000.00), or so much thereof as may be necessary, to be  
 6 used in the following manner:

7 For Title X, improvement expansion of statistical services  
 8 of the state department .....\$ 65,000.00  
 9 Total .....\$880,250.00

 6 1961, and ending June 30, 1963, the sum of seventeen  
 7 thousand dollars (\$17,000.00), or so much thereof as may  
 8 be necessary, to be used in the following manner:  
 9 For the administration and supervision by the department  
 10 of Title V .....\$17,000.00  
 11 2. By renumbering sections three (3) and four (4) as  
 12 sections four (4) and five (5) respectively.  
 13 3. By striking from the last line of Senate File 534  
 14 the figures 380,250.00 and inserting in lieu thereof the  
 15 figures 397,250.00.
