A BILL FOR

An Act to appropriate from the general fund of the state of Iowa eight million dollars (\$8,000,000.00) to the department of public instruction for supplemental aid to certain school districts of the state, as provided by chapter two hundred eighty-six (286), Code, 1958.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated from the general fund
2 of the state of Iowa to the department of public instruction for
3 each year of the biennium beginning July 1, 1961, and ending
4 June 30, 1963, the sum of four million dollars (\$4,000,000.00),
5 or so much thereof as may be necessary, for supplemental aid to
6 such school districts of the state as qualify under provisions
7 of chapter two hundred eighty-six (286), Code 1958, provided,
8 however, that no school district shall receive financial aid under
9 the provisions of said chapter of the Code for reimbursement for
10 any year in which a school tax levy for the general fund of at
11 least fifteen (15) mills was not made in such district.
