A BILL FOR

An Act to make an appropriation from the general fund of the state of Iowa to the department of public instruction for specified school aid.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated from the general
2 fund of the state of Iowa to the department of public instruction
3 for each year of the biennium beginning July 1, 1961, and
4 ending June 30, 1963, the sum of one million nine hundred
5 twenty-one thousand five hundred dollars (\$1,921,500.00), or
6 so much thereof as may be necessary, to be used in the follow-
7 ing manner:

8 Aid to handicapped children (special education as
9 provided in chapter two hundred eighty-one (281),
10 Code 1958)\$1,500,000.00
11 Mining camp schools emergency fund 27,000.00
12 Mining camp schools state aid 45,000.00
13 Normal institute 49,500.00
14 Emergency aid for schools 100,000.00
15 (None of such aid shall be distributed to any
16 school which the department estimates could maintain
17 reasonable educational standards without levying a
18 tax in excess of one hundred (100) mills.)
19 For vocational education aid..... 200,000.00
20 (In addition to the two hundred thousand dollars

21 (\$200,000.00) appropriated for this purpose under
 22 section two hundred fifty-eight point eight (258.8),
 23 Code 1958.
 24 Any unencumbered balance shall revert in the
 25 manner provided by chapter eight (8), Code 1958.
 26 Total\$1,921,500.00
