## A BILL FOR

An Act to legalize and validate the proceedings of the board of directors of the Traer-Clutier Community School District, in the county of Tama, state of Iowa, authorizing and providing for the issuance of school building bonds and for the levy of taxes for the payment of said bonds and declaring the bonds issued pursuant to said proceedings to be enforceable obligations of said school district.

WHEREAS, it appears from the records of the board of directors of the Traer-Clutier Community School District, in the county of Tama, state of Iowa, that at a special school election held in and for said school district on February 15, 1963, the proposition of issuing bonds of said school district in the sum of five hundred thousand dollars for the purpose of carrying out a school building program consisting of building and furnishing an elementary school building and building and furnishing additions to an existing school house situated at Traer, Iowa, was approved by more than sixty per cent of the total number of votes cast for and against said proposition, and in reliance upon said election said board of directors thereafter by resolution authorized and provided for the issuance of school building bonds to the amount and for the purpose aforesaid and made provision for the levy of taxes to pay said bonds and the interest thereon; and

WHEREAS, doubts have arisen concerning the validity and legal sufficiency of said election and proceedings and provisions made for the issuance and payment of said bonds and it is deemed advisable to put such doubts and all others that might arise concerning same forever at rest; now, therefore,

*Be It Enacted by the General Assembly of the State of Iowa:*

- 1 Section 1. That all proceedings heretofore taken by the board
- 2 of directors of the Traer-Clutier Community School District, in
- 3 the county of Tama, state of Iowa, preliminary to and in
- 4 connection with the election on said bonds held in said school
- 5 district on February 15, 1963, and providing for the issuance
- 6 and delivery of school building bonds of said school district in

7 the amount of five hundred thousand dollars pursuant to said  
8 election, and for the levy of taxes to pay said bonds and interest  
9 thereon, are hereby legalized, validated and confirmed and said  
10 school building bonds issued, sold and delivered pursuant to and  
11 in accordance with said proceedings are hereby declared to be  
12 legal and to constitute the valid and binding obligations of said  
13 school district.

1 Sec. 2. This Act being of immediate importance shall be in  
2 full force and effect from and after its passage and publication  
3 in The Traer Star Clipper, a newspaper published at Traer, Iowa,  
4 and The Gladbrook Tama-Northern, a newspaper published at Glad-  
5 Iowa, without expense to the state. brook,

EXPLANATION OF HOUSE FILE 549
