A BILL FOR

An Act relating to hours of duty of members of fire departments.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Section four hundred ten point nineteen (410.19),
- 2 Code 1962, is hereby amended by striking from line seven (7)
- 3 thereof the word "sixty-eight" (68), and inserting in lieu
- 4 thereof the word "fifty-six (56)".
- 1 Sec. 2. The provisions of this Act shall be effective on
- 2 January 1, 1964.

EXPLANATION OF HOUSE FILE 76

Although several cities have granted reductions in the average hours per week of fire fighters, no such reduction has been granted by statute since 1957. This act would standardize fire fighters' hours by providing a maximum work week of an average of 56 hours per week.

By making this act effective on January 1, 1964, instead of July 4, 1963, the cities affected will be able to provide for the additional men needed in their 1964 budget.
