A BILL FOR

An Act relating to special plates for motor vehicles to manufacturers, transporters and dealers.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section three hundred twenty-one point one
2 (321.1), Code 1962, is hereby amended by inserting after the word
3 "car" in line six (6) of subsection two (2) the following:
4 "' , new car', 'used car' ".

1 Sec. 2. Section three hundred twenty-one point one (321.1),
2 Code 1962, is hereby further amended by adding thereto the fol-
3 lowing new subsections:

4 1. "'New car' means every motor vehicle designed primarily
5 for carrying nine passengers or less, excluding motorcycles, which
6 has not been sold 'at retail' as defined in chapter three hundred
7 twenty-two (322) of the Code."

8 2. "'Used car' means every motor vehicle designed primarily
9 for carrying nine passengers or less, excluding motorcycles, which
10 has been sold 'at retail' as defined in chapter three hundred
11 twenty-two (322) of the Code previously registered in this
12 state or any other state."

1 Sec. 3. Section three hundred twenty-one point one (321.1),
2 Code 1962, is hereby amended by striking the word "seven"
3 from line three (3) of subsection four (4) and inserting in lieu
4 thereof the word "nine (9)".

1 Sec. 4. Section three hundred twenty-one point fifty-seven
2 (321.57), Code 1962, is hereby amended by striking the words
3 “manufacturer or” from line two (2) thereof.

1 Sec. 5. Section three hundred twenty-one point fifty-seven
2 (321.57), Code 1962, is hereby further amended by striking from
3 lines six (6) to eight (8), inclusive, the following: “, or use
4 in the ordinary course and conduct of his business as a dealer or
5 manufacturer.”.

1 Sec. 6. Section three hundred twenty-one point fifty-seven
2 (321.57), Code 1962, is hereby further amended by adding to the
3 first paragraph at the end thereof the following: “In addition
4 to the foregoing, a new car dealer or a used car dealer may oper-
5 ate or move upon the highways any new or used car owned by him
6 for either private or business purposes without registering the
7 same providing, (a) such new or used car is in the dealer’s in-
8 ventory and is continuously offered for sale at retail, and (b)
9 there is displayed thereon a special plate or plates issued to
10 such dealer as provided in sections three hundred twenty-one
11 point fifty-eight (321.58) to three hundred twenty-one point
12 sixty-two (321.62) of the Code, inclusive.”

1 Sec. 7. Section three hundred twenty-one point fifty-seven
2 (321.57), Code 1962, is hereby further amended by inserting after
3 the word “to” in line twenty-one (21) the following, “any ve-
4 hicles offered for hire.”.

1 Sec. 8. Section three hundred twenty-one point fifty-seven
2 (321.57), Code 1962, is hereby further amended by striking from
3 lines twenty-two (22) and twenty-three (23) the word “manufac-
4 turer;”.

1 Sec. 9. Section three hundred twenty-one point fifty-eight
2 (321.58), Code 1962, is hereby amended by striking from lines one
3 (1) and two (2) the following: "manufacturer, transporter, or".

1 Sec. 10. Section three hundred twenty-one point fifty-eight
2 (321.58), Code 1962, is hereby further amended by inserting after
3 the word "dealer" in line two (2) the words "in new or used cars".

1 Sec. 11. Section three hundred twenty-one point fifty-eight
2 (321.58), Code 1962, is hereby further amended by striking from
3 line three (3) the word "twenty-five" and inserting in lieu
4 thereof the word "thirty-five (35)".

1 Sec. 12. Section three hundred twenty-one point fifty-eight
2 (321.58), Code 1962, is hereby further amended by inserting after
3 the word "hereunder" in line nine (9) the following: ", and all
4 other dealers or transporters may, upon payment of a fee of
5 twenty-five dollars, make an application to the department in a
6 like manner for a like certificate and number and plates as appro-
7 priate to various types of vehicles subject to registration here-
8 under."

1 Sec. 13. Section three hundred twenty-one point fifty-eight
2 (321.58), Code 1962, is hereby further amended by striking from
3 line eleven (11) the following: "manufacturer,".

1 Sec. 14. Section three hundred twenty-one point sixty
2 (321.60), Code 1962, is hereby amended by inserting before the
3 word "the" in line four (4) the following: "an identification of
4 the type of vehicle and if a car, whether it is a new or used car
5 and".

1 Sec. 15. Section three hundred twenty-one point sixty
2 (321.60), Code 1962, is hereby further amended by striking from

3 line ten (10) the words, "pair of special plates shall be three",
 4 and inserting in lieu thereof the words, "special plate or pair
 5 of special plates for new car and used car plates shall be ten".

1 Sec. 16. Section three hundred twenty-one point sixty
 2 (321.60), Code 1962, is hereby further amended by adding thereto
 3 at the end thereof the following sentence: "For all other
 4 special plates the fee for each special plate or pair of special
 5 plates shall be three dollars."

1 Sec. 17. Section three hundred twenty-one point sixty-two
 2 (321.62), Code 1962, is hereby amended by striking from lines
 3 one (1) and two (2) the following: "manufacturer,".

1 Sec. 18. Section three hundred twenty-one point sixty-three
 2 (321.63), Code 1962, is hereby amended by striking from line two
 3 (2) the following: "manufacturer,".

1 Sec. 19. Section three hundred twenty-one point sixty-four
 2 (321.64), Code 1962, is hereby repealed.
