## A BILL FOR

An Act to make appropriations to members of the legislative research committee and legislative advisory committees.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. There is hereby appropriated out of the general  
2 fund of the state of Iowa to the following named persons the  
3 amounts set opposite their respective names in full settlement of  
4 all claims which they may have against the state of Iowa on  
5 account of services rendered as a member of the legislative re-  
6 search committee or a legislative advisory committee established  
7 by the legislative research committee by the authority of sec-  
8 tions two point fifty-five (2.55) and two point fifty-six (2.56),
