A BILL FOR

An Act relating to vacation benefits for employees of the state of Iowa.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Section seventy-nine point one (79.1), Code of
- 2 Iowa, 1962, is hereby amended by striking the words "all
- 3 subsequent years of employment", in line sixteen (16) and
- 4 seventeen (17) and inserting in lieu thereof the following:
- 5 "through the fifteenth (15) year of employment, and four (4)
- 6 weeks vacation after the fifteenth (15) year and all subsequent
- 7 years of employment".

EXPLANATION OF HOUSE FILE 113

Adoption of this act will bring the benefits of employees of the State of Iowa in line with benefits granted to many of the employees of private industry. This will also give recognition to the long time public employee for his years of service to the state, and will tend to give these people additional reason to maintain their careers in public service.
