Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Section three hundred ninety-seven point
- 2 five (397.5), Code 1962, is hereby amended by adding in
- 3 line sixteen (16) after the word "energy" the words "or gas,
- 4 or water".

EXPLANATION OF HOUSE FILE 146

This bill would permit a municipal utility to purchase gas or water for distribution. This would be done by a contract, not to exceed five years, by the governing body of the utility. The law now provides that this can be done for the purchase of electricity, but the law is silent on the purchase of gas or water.
