A BILL FOR

An Act relating to improvement and maintenance of extensions
of primary roads within cities and towns.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section three hundred thirteen point twenty-one
2 (313.21), Code 1962, is hereby amended by striking from lines
3 eleven (11), twelve (12), thirteen (13), and fourteen (14) the
4 words "and the amount of funds expended in any one year shall
5 not exceed twenty-five percent of the primary road construction
6 fund."

1 Sec. 2. Section three hundred thirteen point thirty-six
2 (313.36), Code 1962, is hereby amended by striking lines eight
3 (8) through eleven (11).

EXPLANATION OF HOUSE FILE 189

The purpose of this bill is to eliminate the requirement that no more than 25 percent of the money available to the highway commission may be spent on extensions of primary highways in cities and towns. This is necessary because a recent survey of highway needs showed that about 30 percent of primary highway needs is in cities and towns and because the highway commission can more efficiently and economically program its construction work if there is no annual limitation.
