A BILL FOR

An Act to amend chapter three hundred twenty-one (321), Code 1962, relating to motor vehicles as to fees collectible with respect to titles and liens and as to amounts of various fees to be retained by the counties for administrative services furnished by the county treasurers.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section three hundred twenty-one point forty-
2 two (321.42), Code 1962, is hereby amended by striking the words,
3 "fifty cents" in line seven (7) thereof and by inserting in lieu
4 thereof the following: "one dollar" and by striking the words,
5 "two dollars" in line fifteen (15) thereof and by inserting in
6 lieu thereof the following: "five dollars".

1 Sec. 2. Section three hundred twenty-one point forty-six
2 (321.46), Code 1962, is amended by striking the words, "seventy-
3 five cents" in line twelve (12) thereof and by inserting in lieu
4 thereof the following: "one dollar and fifty cents".

1 Sec. 3. Section three hundred twenty-one point fifty (321.50),
2 Code 1962, is amended by inserting after the words, "one dollar"
3 in line thirty-five (35) thereof the following: "and fifty cents".

EXPLANATION OF HOUSE FILE 229

Purpose of bill is to bring up to date the amounts allowable to counties for motor vehicle administrative service furnished the state by county treasurers. The 50-cent fee below listed has been the same for more than 25 years, others for 13 years, despite more than doubled cost of operation. This loss operation imposed on counties must be made up out of property tax. Fees for administrative service should be sufficient to meet cost of the service. This is basic. Ironic thing is that treasurer is under great risk of personal liability in performing this service. Below is breakdown of present rates and of changes proposed by above bill.
