A BILL FOR

An Act relating to municipal and county participation in area television translator systems.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section four hundred four point eleven (404.11),

2 Code 1962, is hereby amended by adding thereto the following
3 new subsection:

4 "For the construction, acquisition, operation, and maintenance
5 of an area television translator system except that municipal
6 corporations which have granted a franchise to a privately
7 owned business or company for cable transmission or translator
8 service shall be prohibited from allocating any money from the
9 recreation fund for the purpose of this subsection."

1 Sec. 2. Section three hundred thirty-two point three (332.3),
2 Code 1962, as amended by section one (1) of chapter two hundred
3 eighteen (218), Acts of the Sixtieth General Assembly, is hereby
4 amended by adding the following subsection:

5 "To construct, acquire, operate, and maintain an area television
6 translator system either individually or jointly with boards
7 of supervisors of other counties."

1 Sec. 3. This Act, being deemed of immediate importance,
2 shall be in full force and effect from and after its passage
3 and publication in The Guthrie Center Times, a newspaper

- 4 published at Guthrie Center, Iowa, and in the Audubon County
- 5 Journal, a newspaper published at Exira, Iowa.

EXPLANATION OF HOUSE FILE 288

This bill will permit cities, towns and counties to use public funds for the construction, acquisition, operation and maintenance of an "area television translator system"; except that any municipal corporation which has granted a franchise to privately-owned business or company for television transmission or translator service will be prohibited from providing such service.

HOUSE FILE 288

- 1 Amend House File 288 as follows:
- 2 1. Section 1, line 5, by inserting a period
- 3 after the word "system" and adding the following: "All or
- 4 any part of the apparatus and mechanical devices of any such
- 5 translator system may be located outside of the corporate
- 6 limits of a city or town."
- 7 Further amend section 1, line 5, by striking
- 8 the words "except that municipal" and inserting in lieu
- 9 thereof the word "Municipal".
- 10 2. By striking all of section 2.
- 11 3. By renumbering the remaining section.
- 12 4. Amend the title to House File 288, line 1, by
- 13 striking the words "and county".
