A BILL FOR

An Act to legalize and validate the proceedings for the merger of certain land into the United Community School District, in the counties of Boone and Story, state of Iowa; and declaring the boundaries of said school district to be legally established.

WHEREAS, a school corporation which is known and has been officially designated as the "United Community School District, in the counties of Boone and Story, state of Iowa," was organized under the provisions of chapter two hundred seventy-five (275), Code 1954, as amended, and has been continuously organized and existing since July 1, 1955; and

WHEREAS, pursuant to authority contained in section two hundred seventy-five point forty (275.40), Code 1962, as amended, and proceedings taken by the boards of education of Boone and Story counties, Iowa, and the boards of directors of the United Community School District, and an election held on May 4, 1964, the area contained within the former Douglas Number Three Independent School District, in Boone county, Iowa was merged into said United Community District, effective July 1, 1964, and complete written descriptions of the boundaries of the new and enlarged United Community School District were filed with the county auditors of Boone and Story counties, Iowa; and

WHEREAS, doubts have arisen concerning the validity and legal sufficiency of the proceedings taken for the merger of the aforesaid area of land into the United Community School District, in the counties of Boone and Story, state of Iowa, and it is deemed advisable and necessary to put such doubts and all others that might arise concerning same forever at rest; NOW, THEREFORE,

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. That all proceedings heretofore taken relating
- 2 to and in connection with the merger into the United Community
- 3 School District of the area contained within the former
- 4 Douglas Number Three Independent School District are hereby
- 5 legalized, validated and confirmed, and the boundaried of

6 said United Community School District, in the counties of
7 Boone and Story, state of Iowa, as now shown by the records
8 of the county auditors of Boone and Story counties, Iowa, are hereby
9 declared to be the legally established boundaries of said
10 school district.

1 Sec. 2. This Act being of immediate importance shall be in
2 full force and effect from and after its publication in
3 The Boone News-Republican, a newspaper published at Boone, Iowa,
4 and in the Ames Daily Tribune, a newspaper published at
5 Ames, Iowa, without expense to the state.

EXPLANATION OF HOUSE FILE 35

Legalizing act concerning merger of certain lands into United Community School District of Boone and Story counties.

HOUSE FILE 35

1 Amend House File 35 by adding at the end of
2 section 1 thereof: In the event an appeal is per-
3 fected to the Supreme Court of the State of Iowa
4 from a District Court decision of May 12 in this
5 matter by August 15, 1965, this act shall become
6 null and void.
7 Amend the title to House File 35, line 5, by
8 striking the period and adding "provided however
9 an appeal is not perfected from pending proceedings."
