A BILL FOR

An Act to legalize and validate the proceedings of the board of directors of the United Community School District, in the counties of Boone and Story, state of Iowa, authorizing and providing for the issuance of school building bonds and for the levy of taxes for the payment of said bonds and declaring the bonds issued pursuant to said proceedings to be enforceable obligations of said school district.

WHEREAS, it appears from the records of the board of directors of the United Community School District, in the counties of Boone and Story, state of Iowa, that at a special school election held in and for said school district on December 14, 1964, the proposition of issuing bonds of said school district in the amount of seven hundred thousand dollars for the purpose of building and furnishing a new schoolhouse and procuring a site therefore was approved by more than sixty per cent of the total number of votes cast for and against said proposition, and in reliance upon said election said board of directors thereafter by resolution authorized and provided for the issuance of school building bonds to the amount and for the purpose aforesaid and made provision for the levy of taxes to pay said bonds and the interest thereon; and

WHEREAS, doubts have arisen concerning the validity and legal sufficiency of said election and proceedings and provisions made for the issuance and payment of said bonds and it is deemed advisable to put such doubts and all others that might arise concerning same forever at rest; NOW, THEREFORE,

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. That all proceedings heretofore taken by the
- 2 board of directors of the United Community School District,
- 3 in the counties of Boone and Story, state of Iowa,
- 4 preliminary to and in connection with the election on
- 5 said bonds held in said school district on December 14, 1964,
- 6 and providing for the issuance and delivery of school

7 building bonds of said school district in the amount of
8 seven hundred thousand dollars pursuant to said election,
9 and for the levy of taxes to pay said bonds and interest
10 thereon, are hereby legalized, validated and confirmed and
11 said school building bonds issued, sold and delivered
12 pursuant to and in accordance with said proceedings are
13 hereby declared to be legal and to constitute valid and
14 binding obligations of said school district.

1 Sec. 2. This Act being of immediate importance shall be
2 in full force and effect from and after its passage and
3 publication in The Boone News-Republican, a newspaper
4 published at Boone, Iowa, and the Ames Daily Tribune, a
5 newspaper published at Ames, Iowa, without expense to the
6 state.

EXPLANATION OF HOUSE FILE 36

Legalizing act concerning issuance and payment of school building bonds for United Community School District of Boone and Story counties.

HOUSE FILE 36

1 Amend House File 36 by adding at the end of section
2 1 thereof: In the event an appeal is perfected to the
3 Supreme Court of the State of Iowa from a District Court
4 decision of May 12 in this matter by August 15, 1965,
5 this act shall become null and void.
6 Amend the title to House File 36, line 7, by
7 striking the period and adding "provided however an ap-
8 peal is not perfected from pending proceedings."
