A BILL FOR

An Act to increase the amounts of certain fees collected by the clerk of the district court.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Section six hundred six point fifteen (606.15),
- 2 Code 1962, is hereby amended as follows:
- 3 1. By striking from line one (1) of subsection two (2)
- 4 the words "one dollar" and inserting in lieu thereof the words
- 5 "two dollars".
- 6 2. By striking from line one (1) of subsection three (3)
- 7 the word "three" and inserting in lieu thereof the word "five".
- 8 3. By striking from lines one (1) and two (2) of sub-
- 9 section four (4) the words "one dollar" and inserting in
- 10 lieu thereof the words "two dollars".
- 11 4. By striking from line two (2) of subsection six (6)
- 12 the word "two" and inserting in lieu thereof the word "five".
- 13 5. By striking from line two (2) of subsection seven (7)
- 14 the words "one dollar" and inserting in lieu thereof the words
- 15 "two dollars".
- 16 6. By striking from line one (1) of subsection eight (8)
- 17 the words "thirty cents" and inserting in lieu thereof the
- 18 words "one dollar".
- 19 7. By striking from line two (2) of subsection eleven (11)
- 20 the words "one dollar" and inserting in lieu thereof the words
- 21 "two dollars".

22 8. By striking from line one (1) of subsection thirteen
23 (13) the words "one dollar" and inserting in lieu thereof the
24 words "two dollars".

25 9. By striking from lines one (1) and two (2) of subsection
26 fifteen (15) the words "fifty cents" and inserting in lieu
27 thereof the words "one dollar".

28 10. By striking from line two (2) of subsection sixteen (16)
29 the words "one dollar" and inserting in lieu thereof the words

32 (17) the words "one dollar" and inserting in lieu thereof the

35 (18) the words "one dollar" and inserting in lieu thereof the

38 (20) the words "fifty cents" and inserting in lieu thereof the

40 14. By striking from line three (3) of subsection twenty-
41 one (21) the word "twenty" and inserting in lieu thereof the
42 word "fifty".

43 15. By striking from line two (2) of subsection twenty-
44 two (22) the words "one dollar", and inserting in lieu thereof
45 the words "two dollars".

46 16. By striking from line three (3) of subsection twenty-
47 six (26) the words "twenty" and inserting in lieu thereof the
48 word "fifty".

49 17. By striking from line one (1) of subsection twenty-
50 eight (28) the word "three" and inserting in lieu thereof the

51 word "ten".

52 18. By striking from line two (2) of subsection thirty

53 (30) the words "one dollar" and inserting in lieu thereof the

54 words "two dollars".
