A BILL FOR

An Act relating to the state fair board.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section one hundred seventy-three point one (173.1),

2 Code 1962, is hereby amended as follows:

3 1. By striking lines one (1) and two (2) of subsection two (2)

4 of such section and inserting in lieu thereof the following:

5 "One (1) director from each congressional district and three

6 (3) directors at large, to be".

7 2. By striking subsection three (3) of such section and in-

8 serting in lieu thereof the following:

9 "A president and vice-president to be elected by the state fair

10 board from the ten (10) elected directors."

11 3. By adding thereto the following subsection:

12 "A secretary and a treasurer to be elected by the state fair

13 board."

1 Sec. 2. Section one hundred seventy-three point five (173.5),

2 Code 1962, is hereby amended by striking subsection one (1) of

3 such section and inserting in lieu thereof the following:

4 "A successor to each of the three (3) directors at large whose

5 term expires at noon on the day following the adjournment of the

6 convention. No two (2) directors at large shall be elected from

7 the same congressional district."

1 Sec. 3. Section one hundred seventy-three point six (173.6),
2 Code 1962, is hereby amended by striking all of such section
3 after the word "years." in line three (3) and inserting in lieu
4 thereof the following:

5 "No person shall hold the office of president for more than
6 three (3) consecutive years. The term of a director shall begin
7 at noon on the day following the adjournment of the convention at
8 which the director was elected and shall continue until a successor
9 is elected and qualified as provided in this chapter."

1 Sec. 4. Section one hundred seventy-three point eight (173.8),
2 Code 1962, is hereby amended by striking from line three (3) the
3 word "ten" and inserting in lieu thereof the word "twenty-five
4 (25)".

1 Sec. 5. Section one hundred seventy-three point ten (173.10),
2 Code 1962, is hereby amended by striking from lines two (2) and
3 three (3), the words "general assembly" and inserting in lieu there-
4 of the words "state fair board".

1 Sec. 6. Section one hundred seventy-three point sixteen
2 (173.16), Code 1962, is hereby amended by adding thereto the
3 following:

4 "An individual member of the state fair board shall not be
5 personally liable because of any act performed or debt created by
6 action of the board in carrying out the purposes and provisions
7 of this chapter."

1 Sec. 7. All members of the state fair board serving as of the
2 effective date of this Act shall continue to serve in such capacity
3 until such time as successors and new members can be elected and
4 qualified as prescribed in sections one (1) and two (2) of this
5 Act.

EXPLANATION OF HOUSE FILE 498

The purpose of this bill is to enlarge the membership of the state fair board, to provide for the selecting of officers from the personnel of the board, to make more realistic the per diem pay of the members, to give the board the responsibility of fixing the secretary's salary, and to protect individual members from personal liability for action taken by the board.
