An Act to change the bounty on wolves.

Be It Enacted by the General Assembly of the State of Iowa: *passed house as
amended 5/5 (103-1)*

- 1 Section two (2) of chapter two hundred twenty-six (226), Acts
- 2 of the Sixtieth General Assembly, is amended as follows:
- 3 1. By striking from line four (4) the word and figure "ten
- 4 (10)" and inserting in lieu thereof the word and figure "five
- 5 (5)".
- 6 2. By striking from line five (5) the word and figure "four
- 7 (4)" and inserting in lieu thereof the word and figure "two (2)".

EXPLANATION OF HOUSE FILE 57

The purpose of this bill is to lower the bounty on wolves so as to conform with that paid by Nebraska and Kansas in order to discourage claims for bounties in Iowa on wolves from adjoining states.

HOUSE FILE 57 (Corrected as of February 18, 1965)

- 1 Amend House File 57 as follows:
- 2 1. By striking all after the enacting clause and inserting
- 3 in lieu thereof the following:
- 4 "Section 1. Section three hundred fifty point one (350.1),
- 5 Code 1962, as amended by chapter two hundred twenty-six (226),
- 6 Acts of the Sixtieth General Assembly, section three hundred
- 7 fifty point two (350.2), Code 1962, as amended by chapter two
- 8 hundred twenty-six (226), Acts of the Sixtieth General Assembly,
- 9 and section three hundred fifty point three (350.3), Code 1962,
- 10 are hereby repealed.
- 11 Sec. 2. The board of supervisors of each county may by
- 12 resolution adopted and entered of record authorize the
- 13 payment of bounties from the county treasury for wild animals
- 14 caught and killed within the county. No such bounty shall
- 15 exceed five dollars per animal."
- 16 2. Amend the title by striking the word "wolves" and inserting
- 17 in lieu thereof the words "wild animals".
