An Act relating to salaries of bailiffs and clerks of the municipal court.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Section six hundred two point forty-nine (602.49),
- 2 Code 1962, as amended by chapter three hundred twenty-one (321),
- 3 Acts of the Sixtieth General Assembly, is further amended as follows:
- 4 1. By striking from line five (5) the words "four thousand two
- 5 hundred" and inserting in lieu thereof the words "six thousand
- 6 two hundred (6,200)".
- 7 2. By striking from line seven (7) the words "five thousand"
- 8 and inserting in lieu thereof the words "seven thousand (7,000)".
- 9 3. By striking from line nine (9) the words "five thousand
- 10 eight hundred" and inserting in lieu thereof the words "seven
- 11 thousand eight hundred (7,800)".
- 12 4. By striking from line twelve (12) the words "seven thousand"
- 13 and inserting in lieu thereof the words "nine thousand (9,000)".
- 14 5. By striking from line thirteen (13) the word "The" and by
- 15 striking all of lines fourteen (14) through seventeen (17) thereof.
- 16 6. By striking from line nineteen (19) the words "four thou-
- 17 sand" and inserting in lieu thereof the words "six thousand
- 18 (6,000)".
- 19 7. By striking from lines twenty (20) and twenty-one (21)
- 20 the words "four thousand seven hundred" and inserting in lieu

21 thereof the words "six thousand seven hundred (6,700)".

22 8. By striking from line twenty-three (23) the words "five
23 thousand five hundred" and inserting in lieu thereof the words
24 "seven thousand five hundred (7,500)".

25 9. By striking from lines twenty-five (25) and twenty-six
26 (26) the words "six thousand eight hundred" and inserting in
27 lieu thereof the words "eight thousand eight hundred (8,800)".

28 10. By striking all of lines twenty-eight (28) through
29 thirty-one (31).

EXPLANATION OF HOUSE FILE 585

This bill increases salaries of municipal court bailiffs and clerks \$2,000 a year. They have not had an increase since 1959. Due to the increase in salary above set forth, the \$200 extra compensation now provided for when the judge of the municipal court acts as judge of the juvenile court is eliminated.
