A BILL FOR

An Act to appropriate from the general fund of the state of Iowa to the department of public instruction ten thousand dollars (\$10,000.00) for use as a revolving fund for the veterans administration, and five thousand dollars (\$5,000.00) for the school lunch program.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated from the general fund
2 of the state for the biennium beginning July 1, 1965, and ending
3 June 30, 1967, to the department of public instruction the sum
4 of ten thousand dollars (\$10,000.00), or so much thereof as may
5 be necessary for the use of the veterans education program to be
6 used as a revolving fund to pay salaries and travel of personnel
7 which will be reimbursed by the veterans administration.

8 Total\$10,000.00

1 Sec. 2. There is hereby appropriated from the
2 general fund of the state for the biennium beginning
3 July 1, 1965, and ending June 30, 1967, to the depart-
4 ment of public instruction the sum of five thousand
5 dollars (\$5,000.00), or so much thereof as may be
6 necessary to be used as a revolving fund to cover
7 warehousing, handling, and transportation of direct
8 distribution of federal surplus commodities which
9 will be reimbursed by charging pro rata costs of
10 these items to receiving schools and institutions.

12 Grand total of all appropriations for all purposes
13 of this Act for each year of the biennium for the
14 department of public instruction\$15,000.00

1 Sec. 3. Chapter eight (8), Code 1962, shall apply to this
2 Act.

"five" and "(\$5,000.00)".
