# A BILL FOR

*passed on file 4/29  
Appropriations 5/4  
be amended + pass 5/7*

An Act to make appropriations to the appointive members of the Capitol Planning Commission for per diem compensation for services rendered in past biennium.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. There is hereby appropriated out of the general  
2 fund of the state to the following named persons the amounts  
3 set opposite their respective names in full settlement of all  
4 claims which they may have against the state on account of per  
5 diem compensation for services rendered as appointive members  
6 of the Capitol Planning Commission, to wit:

1 Sec. 2. The state comptroller is hereby authorized to issue  
2 his warrants to the above-named parties in the amounts stated,  
3 and the treasurer is hereby directed to pay the same from the  
4 designated funds or accounts of the state of Iowa.

1 Sec. 3. The acceptance of said sums by the above-named parties  
2 shall be in full settlement of all claims against the state of  
3 Iowa growing out of the above-described claims.

1    Sec. 4. This Act being deemed of immediate importance shall  
 2 take effect and be in full force from and after its publication  
 3 in ....., a newspaper published in  
 4 ....., Iowa, and in .....,  
 5 a newspaper published in ....., Iowa.

EXPLANATION OF HOUSE FILE 656

This bill would provide compensation for members of the Capitol Planning Commission other than members who are on the state payroll. Such members have rendered services and been reimbursed only for mileage and expenses.
